



2023 HIGHLIGHTS

Last year, the LSCP celebrated a quarter century of serving Marquette County businesses and communities as the go-to resource for economic development information and services. Here are some highlights the LSCP celebrated in 2023:

Childcare SPARK combines the best of business development principles, business accelerator practices, and early childhood education knowledge to assist participants in quickly standing up in-home childcare businesses.

- · All three initial participants now have licenses and are open.
- Four additional participants in the new hybrid version.
- Anticipated regional expansion underway.

Childcare SPARK is generously funded through investments by Marquette County and the Statewide Equity Fund

The **Marquette County Housing Target Market Analysis** provides critical data on current and future market trends for housing including demand, demographics, and more. Having such data available removes a

- barrier to encouraging new housing development.Final draft available on marquette.org/housing.
- · Data already being used in discussions with developers and local governments.
- · Public rollout will include deep dive sessions with the consultant who authored report.

The Housing TMA was made possible through support by the MCLBA, LSCP, 7 local governments, DTE Foundation, CFMC, and MDARD.







The Marquette County Land Bank Authority, LSCP, InvestUP, and Community Foundation of Marquette County collaborated to secure a Rural Readiness Grant to hire a **Housing Specialist** who will provide critical capacity for developers and local governments seeking to add new and rehabbed housing stock.

- Antonio Adan appointed as Housing Specialist for Marquette County.
- Position now coordinating Housing Taskforce, Emerging Developer events, and more.
- Efforts underway to secure additional funding.

The initial funding for this position was made possible by MCLBA, LSCP, InvestUP, and CFMC, and the Office of Rural Prosperity.

The **Marquette Sawyer Air Service Demand and Leakage Study** provides critical insight into market forces we are contending with as we seek to re-establish and expand service at our regional airport. A previous version of the study resulted in the MQT-MSP route.

- Final report received and shared with collaborating air service group, but edits and expansion likely needed.
- Direct visits to airlines expected.
- Foundation for larger airport strategic planning efforts also launching.

Funding for this study was provided by Marquette Sawyer Airport, Eagle Mine, Travel Marquette, and LSCP Chairman's Circle.

The LSCP serves as the coordinating partner for the **Central U.P. Small Business Support Hub**, a collaboration of seven strategic partners. The Hub will coordinate and expand access to small business support resources across a seven county region.

- Program Manager onboard.
- Grant agreement executed with MEDC.
- New Resource: Placer.ai
- Partners are hiring Small Business Resource Navigators.

The Hub is made possible through \$3.4 million in ARPA funding awarded by the MEDC.


